Jesus Morales stood on Iraqi soil as the New Year rang in around the world. He and his family spent the holiday season separated by 6,881 miles. As the world rang in the New Year, he looked forward to his release from the military this summer. His New Year wish is to come home and spend time with his young son and family.

While Morales served in Iraq he missed the birth of his son and the last three Christmases with his family. Over the last three years, his unit, the 2nd

"Jackson County government endeavored to maintain critical services to its residents in 2010 despite cutting its spending by almost 20 percent," said County Executive Mike Sanders.


"And despite its strides toward reforms and greater economic stability, the government and its newly seated Legislature have more work to accomplish," Sanders said during his annual State of the County address this week.

Brigade, 25th Infantry Division, Tropic Lighting, Pacific Command, have been deployed to Iraq. It is a fact that he doesn't like, but knows that it is his duty to serve where he is sent.

"It isn't that bad for me being over here in Iraq during the holidays because I have been here so much, but I can tell you it is hard for my soldiers," he said.

While the holidays are hard for the soldiers Morales wonders if they are not being forgotten by the rest of the country. To Morales, it seems that people have lost interest in the war and the men and women who are serving.

"Care packages are sent year round but they (organizations or individuals) do not send them as much as they use to when we first came here," said Jesus.

His wish for the New Year is that soldiers would be remembered year-round because it is a morale booster for them. He suggested that care packages should contain items that will help entertain the soldiers. "We play monopoly and NCAA, anything that helps us to take our mind off [home] and what family and friends are doing," he said.

su familia. Durante los últimos tres años, su unidad, la Brigada Segunda, 25<sup>ta</sup> División de Infantería, Relámpago Tropical, Comando del Pacífico, han sido desplegados a Irak. Es un hecho que a él no le gusta pero sabe que es su deber servir a donde se envíe.

"Jugamos el monopolio y la NCAA, cualquier cosa que nos ayude a no pensar en la casa y lo que la familia y amigos están haciendo", dijo él.

Even though they had a small Christmas celebration, it is not like his Christmas celebration with his family. "We will eat at the chow hall and they will serve turkey but no tamales," he said. "I miss the tamales that my family has and going to midnight mass with my family. I miss my son and my grandma Manuela "Nellie" Morales who passed away in May."

His brother Vincent Morales also served three tours of duty in Iraq over the holidays so he understands the loneliness of the holidays for his brother and the other soldiers. He also worries about his brother and when they talk by phone or through their emails he tries to keep his spirits up with jokes or good-natured ribbing.

The holidays are difficult and you need to find something to do with your down time. Keeping yourself occupied worked for me so that I wasn't thinking of the holidays and what your families are doing or how your kids are. They do small things there for the soldiers but that made it harder for me over the holidays. In the back of your mind you are always thinking how much better it would be to be with your family," he said.

Neither brother questioned why they were being sent back to Iraq for a third tour -they knew it was their job and they served without question. But their service came with a high price tag for their families. In addition to missing out in the first three years of his son's life, the stress of military life led to the dissolution of his marriage.

According to a study being conducted by the military, divorce rates are climbing among soldiers. Joe Davis, spokesman for the organization Veterans of Foreign Wars was quoted in a recent article in the Washington Post.

"In the 2009 fiscal year that ended Sept. 30, there were an estimated 27,312 divorces among the nearly 765,000 married members of the active-duty Army, Air Force, Navy and Marine Corps, according to figures provided by the Pentagon. The force is under tremendous stress, and that stress finds its way into marriages," said Davis.

The two brothers' lives seem to parallel one another as they both enlisted in the military, they both have spent three tours of duty in Iraq, they both have lost time with their spouses and children and they both have had their marriages end in divorce.

"I had a difficult transition back into civilian life. When I came back my wife divorced me. I went back to school, I was unemployed for four to six months and I had to move in with my father. I know that my brother's biggest concern when he gets out is will he have employment. He wants to spend time with his son and when you are in the military you have a steady paycheck, you have health care, you don't have to worry, but when we get out, jobs are not always easy to find," said Vincent Morales.

Vincent told Hispanic News that his brother has learned a valuable trade that he can use when he gets out of the military. Jesus is a mechanic and can work with machinery and engines. "The skill I acquired in the military had to do with explosives. I was more of a war fighter type and my skill doesn't translate over to a daily basis," he said.

He credits his father with standing by him and helping him through the readjustment period. Vincent is

attending college during the day, working nights for FedEx and during his free time he is a personal trainer.

"My father helped me [at] a time when I needed him most, when I was getting divorced and I didn't have anywhere to live. We will be here for my brother when he gets out and we will be here to give him a helping hand," he said.

as an opportunity to raise the bar of expectations for county government and to solve problems with unique and innovative solutions."

Sanders delivered his speech after an inauguration ceremony on Tuesday at the downtown Courthouse. Crystal Williams, the Legislature's newest member and second woman on the governing body, was sworn in as the 2nd District at-large representative.

Sanders, who also was sworn in for another term, announced during his address a 3-percent merit raise pool for county workers this year.

"Today provides us an opportunity to recognize the sacrifices our employees have made and to reward them for what they have done," he told the crowd. "Jackson County will take a back seat to no one as we continue to recruit and retain the best employees possible."

Sanders said the raises would be awarded to the county's best performing workers.

After the ceremony, Williams said she was excited to begin her term. "I am so looking forward to working for the people of Jackson County."

She said one of the first tasks of the Legislature is to begin budget hearings this week, which will include discussion of the merit-based pay raises.

"We have to look at how we are spending our money and we have to figure out what the priorities are," she said. "Certainly, the employees of the county should be one of our top priorities."

Theresa Garza-Ruiz, who began her second term in office on Tuesday as the 1st District at-large legislator, said she remains dedicated to the community and to county workers. "They are the ones who actually do the work, and we do have some of the lowest paid county workers in the state of Missouri."

Sanders said the county must continue to maintain its high performance standards and avoid any tax hikes as a quick budget fix.

"We continue to be steadfast in the belief that Jackson County government must live within its means," he said. "If this is the reality of the families who live in our county, then

their government should be required to live up to the same high standard."

He also pledged to continue working with neighboring government entities to provide quality services while bringing down the costs of those services. One example, he said, was the Regional Correctional Center, which he described as a success.

"Regional cooperation is essential if our community is going to remain viable and competitive in the new millennium," he said.

Completing the renovations to the Truman Courthouse in Independence, the expansion of the county's Little Blue Trace Trail and studying a regional transportation system are other goals Sanders said he wants to focus on this year.

"Now is not the time to settle for the results of the past, but it is time to get to work building the future," he said. "It is time to begin looking beyond this year or the next election and start planning for the next generation."

# Healthcare Reforms Kick Into Gear

The Patient Protection and Affordable Care Act President Obama signed on March 23, 2010, set in motion a wide range of healthcare reforms. Although many of its more sweeping changes won't be fully activated until 2014, several key elements already went live, effective September 23, 2010.

If you have employer-provided health insurance that runs on a calendar year, this means those new features will finally kick in on January 1, 2011. If you have individual coverage, you may have already seen the changes; but if your plan's fiscal year starts later, you may have to wait awhile longer.

Here are a few noteworthy changes:

**Extended child coverage.** If your medical plan offers dependent coverage, your children may now remain on – or return to – your plan until their 26th birthdays, regardless of where they live, or their dependent, income or marriage status. You will be responsible for paying the additional premium at the plan's already established family or per-child rate.

**One notable exception:** If your plan is "grandfathered" (i.e., already existed on March 23, 2010), the carrier has the right, until 2014, to deny such

coverage if your child has other employer-sponsored coverage. However, plans lose their grandfathered status if they significantly cut benefits or increase out-of-pocket expenses.

**Pre-existing conditions for children.** Medical plans can no longer deny coverage to children under age 19 because of preexisting health conditions, unless you have an individually purchased, grandfathered plan. The same provision will go into effect for adults in 2014.

Some insurers have threatened to stop offering individual child policies altogether as a way to avoid having to cover seriously ill children, so double check with your carrier.

**Rescinding coverage prohibited.** Plans can no longer cancel coverage if you become sick or you made minor or inadvertent mistakes on your application that only later came to light. However, deliberate fraud, such as falsely claiming a dependent, can still result in cancellation.

**No more lifetime limits.** Non-grandfathered plans can no longer cut off benefits when you reach a lifetime maximum. In addition, annual coverage limits for non-grandfathered plans have begun phasing out and will be completely banned starting January 1, 2014. Important note: Several companies that offer limited-benefit coverage to

low-wage workers who otherwise couldn't afford coverage recently won a one-year exemption from the annual coverage limit. Ask your employer department if you're unsure about your plan.

**New coverage for the uninsured.** If you've been refused insurance because of preexisting medical conditions, you now may be eligible to buy coverage through a new "high-risk pool" program. Although it's a federal program, many states have chosen to run their own plans, with widely varying costs and benefits. A few details:

- You must be a U.S. citizen or legal resident.
- You must have been without health insurance for at least six months before you can apply.

• You must have a qualifying preexisting condition and show proof that an insurance company has denied or excluded coverage because of it.

• Go to <https://www.pcip.gov/> for information and to apply online; or call the state department of insurance. AARP also has a thorough discussion about how the program works.

## Las reformas del sistema de salud entran en funcionamiento

La Ley de Protección al Paciente y Cuidado de Salud Asensible aprobada por el Presidente Obama el 23 de marzo de 2010, ponen en movimiento una amplia variedad de reformas relacionadas con la salud. Si bien muchos de los cambios más notables no regirán sino hasta el año 2014, varios componentes clave ya entraron en vigencia a partir del 23 de septiembre de 2010.

Si usted posee un seguro de salud proporcionado por el empleador con vigencia durante un año calendario, esto significa que las nuevas implementaciones finalmente entrarán en funcionamiento a partir del 1 de enero de 2010. Si posee una cobertura individual, posiblemente ya haya percibido estos cambios; pero si el año fiscal de su plan comienza más tarde, tendrá que esperar un poco más.

A continuación, algunos cambios destacados:

**Extensión de la cobertura infantil.** Si su plan de salud ofrece cobertura para dependientes, sus hijos ahora pueden permanecer en su plan – o volver a él – hasta que cumplan los 26 años, independientemente del lugar donde vivan, o de su estado de dependiente, ingresos o civil. Usted será responsable del pago de la prima adicional conforme el precio establecido del plan familiar o por hijo.

**Una excepción notable:** Si su plan es "antiguo" (es decir, que ya existía al 23 de marzo de 2010), la aseguradora tiene derecho, hasta el año 2014, de denegar la cobertura en caso de que su hijo cuente con cobertura de empleador. No obstante los planes pierden su condición de antigüedad si éstos reducen significativamente los beneficios o aumentan los gastos de bolsillo.

**Condiciones preeexistentes de los hijos.** Los planes de salud ya no pueden denegar la cobertura a los hijos menores de 19 años a causa de condiciones de salud preeexistentes, a menos que usted cuente con un plan antiguo adquirido individualmente. La misma disposición entrará en vigencia para los adultos en el año 2014.

Algunas aseguradoras amenazaron con dejar de ofrecer pólizas individuales para hijos como una manera de evitar tener que cubrir a niños con enfermedades graves, por lo tanto, verifique esto con su aseguradora.

Se prohíbe la rescisión de la cobertura. Los planes ya no pueden cancelar la cobertura en caso de que usted se enferme o

si comete algún error leve o no intencional en su solicitud que luego salga a luz. No obstante, el fraude intencionado, como declarar falsamente que posee un dependiente, puede ser motivo de rescisión.

No más límites de por vida. Los planes sin antigüedad ya no pueden recortar beneficios cuando usted alcance el límite máximo de por vida. Además, los límites anuales de la cobertura para los planes sin antigüedad han comenzado a eliminarse y estarán totalmente prohibidos a partir del 1 de enero de 2014. Nota importante: Recientemente se otorgó una exención al límite de cobertura anual a varias compañías que ofrecen cobertura con beneficios limitados a trabajadores de bajos ingresos que de otro modo no podrían pagar la cobertura. Consulte en la oficina de su empleador si no está seguro acerca de su plan.

Nueva cobertura para quienes no están asegurados. Si se le denegó la cobertura debido a una condición de salud preeexistente, ahora podría ser elegible para adquirir una cobertura a través del programa "high-risk pool". Si bien se trata de un programa federal, muchos estados han el-

egido administrar sus propios planes, con costos y beneficios muy variables. Algunos detalles:

- Debe ser ciudadano o residente legal de los Estados Unidos.
- No debe haber tenido seguro de salud por al menos seis meses antes de presentar la solicitud.

• Debe tener una condición preeexistente que califique y presentar comprobante de que una compañía de salud le denegó la cobertura o lo excluyó a causa de dicha condición.

• Visite <https://www.pcip.gov/> para obtener información y presentar la solicitud en línea; o llame al departamento de seguro. AARP también explica en detalle el funcionamiento del programa.

## KCK Mayor Joe Reardon reacts to misconduct of Police Officers

"Allegations of misconduct by some members of the KCK Police Department are troubling. As Mayor, I expect the utmost integrity and professionalism from our police officers and so do our citizens. Acts of misconduct should not and will not be tolerated."

At the first suspicion of misconduct, Police Chief Rick Armstrong launched an aggressive internal investigation and called on assistance from the Federal Bureau of Investigation, the US Attorney's Office and the Wyandotte County District Attorney.

That investigation is still underway and there will be details about it made public as quickly as possible. We expect it will be tomorrow.

In the meantime, I want to stress that as Mayor, I have the highest confidence in Police Chief Armstrong and his leadership of the KCK Police Department. I applaud his decision to launch the investigation and fully support the way it is being handled.

As Mayor my expectation is that we continue to have a police department that is responsible to its citizens and fights crime with the upmost integrity. Over the course of the last several years we have achieved great results in reducing crime. The best way to support our community and the hundreds of good police officers that serve each day is to aggressively pursue this investigation.

### FYI Carbon Monoxide: Invisible Winter Hazard Safe Kids Kansas recommends home CO detectors

With the arrival of the winter season comes the arrival of colder weather, as well as an increase in the number of fuel-burning appliances being used in the home. These appliances include ovens, space heaters, generators, indoor grills and fireplaces, and they can cause dangerous levels of carbon monoxide (CO) to build up in the home.

"Families today are better at understanding the importance of having working smoke alarms in every sleeping area, but what about carbon monoxide alarms?" says Cherie Sage, State Director of Safe Kids Kansas. "Carbon monoxide is so dangerous because it is odorless, invisible, and it can kill. CO can make a child seriously ill in small doses that might not noticeably affect an adult."

According to a study from 2004 to 2006, children

younger than five years old have the highest estimated rate of CO-related visits to the emergency room each year among all age groups in the United States. Nationally, more than 25 kids die from CO poisoning every year.

Important safety tips to protect families from CO poisoning:

- Prevent CO buildup in the first place - make sure heating appliances are in good working order and used only in well-ventilated areas.
- Don't run a car engine in the garage, even to warm it up; move the car outside first.
- Install a CO alarm outside every sleeping area, on every level of your home and at least 15 feet away from every fuel-burning appliance.
- When you check your smoke alarm batteries each month, check the batteries on your CO alarms at the same time – and replace the batteries twice a year.
- Never use a stove for heating.
- Have all gas, oil or coal burning appliances inspected by a technician

every year to ensure they're working correctly and are properly ventilated.

- If a CO leak is suspected, open windows to allow fresh air into the home. If someone who has been in a poorly ventilated room with a fuel-burning appliance exhibits symptoms including headache, dizziness, fatigue, nausea, vomiting, or confusion, move the victim to fresh air and call 911.

If more than one person in the home suddenly feels ill for no apparent reason, or if a CO alarm goes off, get everyone outside immediately and call 911 from a pre-arranged meeting place. "CO alarms are available at hardware stores for about \$20," adds Sage. "That is a small price to pay to help detect odorless, poisonous gases in the home before it's too late."



we have lost focus on the things that are important for the city," James said. He pledged to install a tough but fair style of leadership that again will make Kansas City's government work for its residents.

A Kansas City native who was raised near 44th and Montgall Avenue and attended Bishop Hogan High School, James said he has a strong passion about fortifying the city's future.

"This is not an agenda for me," he said. "This is an agenda for us, an agenda that is designed to move the city forward, putting efficiency in the budget in a number of ways, enforcing laws and reducing crime on the streets, working hard to make the educational system something we can be proud of as opposed to something that we fear and making sure that jobs are available to people. Those are the four things that we are involved with."

James said his platform helps Kansas City define a plan that it has lacked in recent years. "How do we get anywhere if we don't have a plan? Where are we supposed to be going?"

The plan, he said, should explain what the city has to offer the world and also strategize how to make the city's strengths stronger and reduce weaknesses. Then the plan should determine how the city should market itself on a path that will lead to more jobs and economic opportunity. Finally, the plan must have measurable steps to hold people accountable and show the changes that have occurred.

"Nothing is simple. Nothing is simple, but the energy that I have to try to get it done is simple. If you believe in something you need to go out and attack it. And I'll attack it."

"Otherwise, a city government with no objectives tends to wait for a crisis to occur," he said. "When one crisis is resolved, the government waits for the next crisis. Between each crisis, people start taking

a hard-line position on issues and that breeds hurt feelings and then eventually it's tough for people to work together."

James said he would not only partner with the city council or the city manager, "but partner with the people of the city. The people of the city have to become engaged. They have to see that they have a stake in the city and that they have something to gain by actually participating in the city. The first we have to do is start encouraging people to become active citizens in the city."

As mayor, James said he would re-establish a citizen's commission on municipal revenue — an entity that would look at revenue streams, the tax base, tax-increment financing and how the city is spending money. He said the commission might also look at how other cities are handling their spending and perhaps adopt some of their best practices.

A Vietnam veteran, James graduated cum laude from Rockhurst College before earning his law degree, also cum laude, from the University of Minnesota in 1983. He joined Blackwell, Sanders, Matheny, Weary & Lombardi in 1983, and became the first African-American partner in the firm's history in 1990. In February 2002, James started his own successful small business, The Sly James Firm.

In 1992, the Missouri Supreme Court appointed James to the Missouri Board of Law Examiners. He was president of the Kansas City Metropolitan Bar Association in 2003, director of the Kansas City Bar Foundation, and vice president of the Public Interest Litigation Clinic.

His experience in civic activities is numerous. His service includes an appointment to the board of directors of the Economic Development Corp. of Kansas City and to the board of the Land Clearance for Redevelopment Authority by former Mayor Kay Barnes. James also has been a member and Board Secretary of the Board of Trus-

tees of the Eye Foundation of Kansas City Inc., a member of the Board of The United Way and a member of the Executive Board of the Committee for County Progress.

James said his vast experience with people and organizations will allow him to bring a style of leadership to City Hall that will restore good leadership and a positive attitude about the city and its citizens.

"If we are going to address the problems in this city, we need to first understand that this is one city. It's not six separate council districts. The council people are not kings or queens of their own council district. This is one city. We need a plan to address the entire city, that takes care of the needs of the city, that puts things in priorities and makes sure that everybody knows where we are going and how we are going to get there," James told Hispanic News.

His way of getting to the future will definitely include a city government that listens to its citizens, he said, because he has learned the best ideas come from a broad range of thinkers who shape them.

"The diversity in City Hall does not accurately reflect the diversity of our community. The sad thing about it is that this city has a lot of divisions. We have the state line and we treat it like it's the Berlin wall." said James

that there are no real big differences between people.

"We are people. It has nothing to do with race or color of your skin. It has to do with who you are. I accept people on their own terms. If you're somebody we shouldn't hang out with, then let's not hang out."

James said he didn't want to spend too much time on the legacy of current Mayor Mark

Funkhouser. However, he added, "I don't think this city can afford four more years of not figuring out who it is or where we are going because every day we wait to accomplish that goal is a day that we fall farther and farther behind."

"The mayor's job is to be the face of this city inside and outside the city. The mayor's job is to have a vision and to make sure we are working toward that vision, to be a spokesperson for the city ... to make sure the city thrives and grows."

"Just because it's a weak-mayor form of government doesn't mean you need a weak mayor."

James said Funkhouser misunderstood the mayor's office, which led to problems from the start. He said he would return communication, cooperation, compromise and collaboration to the office if elected.

"I know the city has problems and will likely face more issues in the future. But every minute we spend looking backward at what someone has done is a minute we can't spend looking forward to figure out what we should do."

de cómo abordar las cosas es encontrar las soluciones a los problemas que le importan a la gente, que la gente respeta, pueda aceptar y pueda empujar. Y eso requiere que trabajen en cooperación."

El Ayuntamiento ha "ido de crisis en crisis y de drama en drama, y hemos perdido el enfoque en las cosas que son importantes para la ciudad", dijo James. Se comprometió a instalar un estilo de liderazgo duro pero justo que hará que el gobierno de Kansas City trabaje para sus residentes de nuevo.

Nacido en Kansas City, se crió cerca de la Calle 44 y la Avenida Montgall y asistió a Bishop Hogan High School, James dijo que tiene una fuerte pasión acerca de fortalecer el futuro de la ciudad.

"Esta no es una agenda para mí", dijo él. "Esta es una agenda para nosotros, una agenda que está diseñada para hacer avanzar a la ciudad, haciendo eficiente el presupuesto en una serie de formas, hacer cumplir las leyes, reducir la delincuencia en las calles, trabajar duro para hacer algo al sistema educativo y que puedan estar orgullosos en vez de que sea algo que tememos y segurarse de que los trabajos estén disponibles para la gente. Esas son las cuatro cosas en que estamos involucrados."

James dijo que su plataforma de ayuda a Kansas City es definir un plan del que se ha carecido en los últimos años. "¿Cómo podemos avanzar si no tenemos un plan? ¿Adónde vamos?"

Dijo que la comisión también podría estudiar la forma en que otras ciudades manejan sus gastos y tal vez adoptar algunas de sus mejores prácticas.

Un veterano de Vietnam, James se graduó cum laude de la Universidad Rockhurst antes de obtener su título de abogado, también se graduó cum laude de la Universidad de Minnesota en 1983. Se unió a Blackwell, Sanders, Matheny, Weary y Lombardi en 1983, y

se convirtió en el primer socio afroamericano en la historia de la empresa en 1990. En febrero de 2002, James comenzó su propia empresa pequeña exitosa, The Sly James Firm.

En 1992, la Corte Suprema de Missouri nombró a James a la Junta de Examinadores de la Ley de Missouri. Fue presidente de la Kansas City Metropolitan Bar Association en 2003, director de la Fundación de Abogados de Kansas City, y el vicepresidente de la Clínica de Litigio de Interés Público.

Su experiencia en las actividades cívicas es numerosa. Su servicio incluye nombramiento a la junta directiva de la Corporación de Desarrollo Económico de Kansas City y la dirección de Land Clearance for Redevelopment Authority por la ex alcaldesa Kay Barnes. James también ha sido miembro y Secretario del Consejo de la Junta de Síndicos de la Fundación de Ojos de Kansas City Inc., un miembro de la Junta de United Way y miembro del Consejo Ejecutivo de la Comisión para el Progreso del Condado.

Charlie Singer, senior vice president of Content and Creative for Tr3s, will serve as executive producer, and Jesus Lara as co-producer. The show's producer will be Audrey Morrissey from Live Animals, which will also serve as the production company.

The New York Times hails Los Tigres del Norte as "[Regional Mexican] music's greatest statesmen... Los Tigres sell millions of records, regularly top Billboard's Latin charts and draw tens of thousands of fans to stadiums... In short, they are among the most popular acts in Latin music today". Los Tigres del Norte has received multiple Grammy and Latin Grammy awards, and was awarded the Latin Recording Academy's Lifetime Achievement Award in 2007. Demonstrating their continued standing at the forefront of the genre, Los Tigres has actually won the last four consecutive Grammy Awards for Best Norteño Album, while both their most recent album "La Granja" and its title track/first single again topped the charts at #1.

Juanes commented, "Los Tigres are the rock of the culture. It's an honor to join them for this 'Unplugged'. I love their music, attitude and career." Juanes has become the leading all-Spanish language music artist in the world over the course of the last decade, often mentioned alongside artists such as Bono and Bruce Springsteen for

his belief in the possibility of social change through music. With more than 15 million albums sold and a slew of Grammy and Latin Grammy wins, Juanes' new album "P.A.R.C.E." is already getting high praise and topping the Billboard charts. Using music as his platform for change, the vocalist for the Grammy Award winning, multi-platinum rock band Rage Against the Machine and One Day As A Lion has organized campaigns like The Sound Strike, rallying against Arizona's SB1070 immigration law, and is a proud supporter of United Farm Workers and the National Day Laborer Organizing Network.

From his early beginnings as a keyboardist for Raices, at just 17, to a successful solo career, has become one of the top Spanish rock musicians of our time. A Latin Grammy and Gardel winner, Calamaro is currently showcasing his latest album, "On The

Rock", which is posting among his bestselling albums and increasing his fan base throughout Latin America .
