RIDEKC transit service extends to Lenexa starting Jan. 3

(Kansas City, Mo. –) RideKC will extend transit service to Lenexa from Oak Park Mall, completing a new regional bus route linking Missouri and Kansas.

Starting this week, the 495 95th Street Route will run four miles west to Lenexa's City Center development at 87th Street and Renner Road.

The new route will reach more than 2,300 households and more than 5,500 jobs located within a quarter mile of the route west of Quivira Road.

The route will provide bus service to Lexmark International, as well as the new 200-acre Lenexa City Center, a walkable development that ultimately will include a variety of housing, shops, offices, restaurants, hotels and entertainment venues.

The extension of the 95th Street route completes a service expansion that started last summer when the route was created as part of a service expansion in Johnson County.

The route will run between 74th Terrace and Broadway in the Waldo neighborhood of Kansas City and 87th Street and Renner Road in Lenexa with stops at Ward Parkway Center and Oak Park Mall, among other locations.

Service will run weekdays from 5:45 and 8:30 during the morning rush hour and from 3:30 to 7 p.m. during the afternoon rush hour. One-way fare is \$1.50.

"We are laser-focused on helping people get to work and this new route extension does just that," said Steve Klika, chairman of the Kansas City Area Transportation Authority. "Residents will now have direct connections to jobs at Ward Parkway Center, Oak Park Mall and Lenexa City Center. We think the public will benefit immensely from this route and the opportunities it provides residents on both sides of the state line."

Americans are right to worry about insurance quality

f all their concerns about healthcare, Americans are most worried about whether they can afford their insurance. That's the key finding from a new Morning Consult survey of over 20,000 people.

It's easy to see why Americans are so anxious. Premiums are set to rise sharply next year. And insurers are shifting more of the cost of procedures and medicines onto patients. In short, people are paying more but getting less coverage. In many cases, patients appear to be skipping needed treatments because they can't afford their copays or co-insurance.

Unaffordable insurance is a problem for the nation, not just for individual households. If people don't have quality coverage, they'll be stuck with ineffective treatments. Their conditions can worsen – causing their healthcare costs to balloon.

Rising premiums are crushing family budgets across the nation. More than four out of ten Americans said that their monthly health insurance premiums increased in the past year. Come 2017, insurers will increase premiums for employer-sponsored plans about 5 percent. For Americans who buy coverage on the Affordable Care Act exchanges, premiums will skyrocket 25 percent, on average. Consumers in many states could see their premiums increase 60 percent or more.

Insurers are making patients shoulder a larger share of treatment costs. Four out of ten Americans say that their out of pocket costs have spiked in the past few years, according to the survey. As of 2014, Americans were spending more than triple on their deductibles

than they had a decade prior, according to the Kaiser Family Foundation.

In exchange for the added costs, Americans are receiving less coverage.

Insurers increasingly exclude some providers from networks to squeeze big discounts out of the remaining in-network doctors and hospitals. As a result, four in ten consumers had trouble, or knew somebody who had trouble, finding an innetwork doctor or clinic.

Recently I had a medical issue that required surgery. The cost of the out-of-network surgeon was \$18,000. The insurance company refused to pay the doctor's charge for the surgery. After three long and tedious rounds of appeals, an outside arbitrator deemed that the surgery should be covered since it was an emergency situation. The insurance company paid the surgeon its previously negotiated innetwork fee of \$179.47. The number of in-network doctors, and thus patient's choices, is shrinking.

Firms are also dragging their feet or flat out refusing to pay for certain therapies. Nearly 30 percent of Americans report that their doctor prescribed them a treatment that wasn't covered by insurers. A similar percentage experienced difficulty getting an insurer to cover a needed treatment.

The thinning coverage and bulked up costs mean that healthcare is, in practice, inaccessible for many people, even though they technically have insurance coverage. A majority of Americans either couldn't fill a prescription, or know someone who couldn't, because the cost-sharing requirement was too high.

Consider the story one doctor recently shared about his patient suffering from ulcerative colitis, a chronic disease that causes inflammation in the

large intestine. The doctor had prescribed the 28-year-old woman two medications that got her colitis under control.

But a year later, the woman returned to his office, crying. She was sicker than before. The doctor asked if the medicines had stopped working. She then revealed that she had quit taking them because her insurance company stopped covering the drugs, and she couldn't afford the out of pocket costs.

Going without treatment is bad for patients – and for the nation's healthcare budget. Nearly 60 percent of the population suffers from at least one chronic disease. Preventing and managing these diseases is vastly cheaper than letting them spiral out of control.

Chronic diseases are already projected to cost us \$42 trillion from now until 2030. If insurance quality continues to decline and more patients can't adhere to their treatments, the bill could grow even larger.

Reforms to lower insurance costs and ensure quality coverage would enable patients to better manage their chronic diseases. That would spare them from needless suffering – and the nation from needless healthcare expenditures.

In the current political climate, it is difficult to see quick resolution to this not insurmountable problem. However, amending Obamacare – as was always anticipated by the administration – could resolve the issues.

For millions of Americans, good insurance is a prerequisite for good health. No wonder people are so concerned about their worsening coverage.

BRING PETS INSIDE: leave outside in the cold for prolonged periods of time. Remember thermometers might show one temperature, but wind chills can make it feel much colder. Limit time outdoors and be mindful of frostbite on ears, tail and paws. If you run with your dog, pay attention to cold paws and, if it gets too cold, leave your pup at home. Owned cats should always be kept indoors, as "outdoor" cats can often become victims of road traffic or wild animals and are susceptible to freezing or starving to death in severely cold weather.

ACCLIMATE PETS TO COLD WEATHER:
If pets spend a lot of time outdoors, make sure to introduce them gradually to dropping temperatures, rather than exposing them to the extreme cold all at once.

PROVIDE ADEQUATE **SHELTER:** For outdoor dogs, owners should wellprovide а draft-free, insulated, appropriately sized doghouse. The opening should face south with a sturdy, flexible covering to prevent icy winds from entering. Line the floors of the shelter with straw, not hay. Do not use towels or blankets, which can become damp or freeze.

BEWARE ANTIFREEZE AND ROCK SALT: Antifreeze often collects driveways and Although roadways. it smells and tastes sweet to your pet, it is lethally poisonous. If pets have ingested antifreeze, contact your veterinarian immediately! De-icing products like rock salt

can irritate footpads. Be sure to rinse and dry pets' paws after being outside. Pet stores often carry pet-safe ice melts that do the job and won't harm your pets.

DRY OFF WET PETS:
A wet pet is a cold pet.
Towel or blow-dry pets
if they get wet from
rain or snow. Also, it is
important to clean and
dry paws to prevent tiny
cuts and cracked pads.

PROVIDE PLENTY OF **FOOD** WATER: It takes more energy in the winter to properly regulate body temperature, so pets may need additional calories when spending a lot of time playing or working outdoors. Pets are just as likely to get dehydrated in the winter as in the summer, so be sure to provide plenty of fresh water. Snow is not a substitute for water. Refill outside bowls often to prevent freezing.

CAREFULLY PETS WARM INSIDE: Keep pets warm, dry and away from drafts while inside. Space heaters and other supplemental heat sources burn your pet. Keep portable heaters out of reach and make sure all fireplaces have screening. adequate And, of course, never leave pets alone with an unattended fire.

GROOM
REGULARLY: Pets need a well-groomed coat to keep properly insulated. Short- or coarse-haired dogs might get extra cold so consider a sweater or a coat. Long-haired dogs should have their paw hair trimmed to ease in cleaning and snow removal.

Michael Dean Trego, de Kansas City, Kansas, ha estado desarrollando un tequila que se enfrenta a los mejores bourbons o vinos, pero es accesible para el consumidor.

Después de ocho años en la etapa de desarrollo, Trego, con la ayuda de su esposa Guadalupe, lanzó su propia línea de tequila el pasado mes de octubre. Las marcas de tequila Mi Rancho Blanco, Mi Rancho Reposado y Mi Rancho Añejo han captado rápidamente la atención del consumidor.

Mi Rancho Tequila ganó el premio Spirits International Prestige (SIP, por sus siglas en inglés) en la categoría de platino con 96 puntos de 100 en la competencia de California.

"Fue tan genial entrar en una tienda de licores y verlo en el estante. Vi a alguien comprarlo y, he estado en una tienda de licores cuando alguien entró y lo pidió por su nombre. Te hace pensar que tienes algo valioso, algo de valor. La vida tiene altibajos, pero te permite saber que has hecho algo", dijo. Mi Rancho tequila

Mi Rancho tequila comienza con el agave cultivado en fincas, lo que garantiza un cierto nivel de contenido de azúcar y la calidad de la destilación. La etiqueta plateada es su tequila blanco y embotellada sin añejamiento, sugiriendo típicamente los sabores más puros del agave. Según Trego, su etiqueta plateada está hecha para las bebidas mezcladas.

También está produciendo un tequila almacenado en barriles de whisky, lo que ayuda a mejorar el tequila hasta convertirlo en una bebida más suave.

El tequila se produce al obtener el corazón de la planta del agave, o piña, que puede pesar de 80 a 200 libras cuando se cosecha. El corazón se despoja de las pencas y se cocina para eliminar la savia, que es fermentada y destilada.

Mi Rancho Tequila es un auténtico tequila

premium elaborado con 100% agave azul, en Jalisco, México.

"Nuestro tequila tiene el menor contenido de metanol en el mundo. El metanol es lo que causa una resaca. Después de beber Mi Rancho Tequila por un largo período de tiempo, debido al bajo contenido, no tendrás una resaca", dijo Trego.

El se ha fijado una meta para el 2017, el hacer crecer la marca un 20 a 25 %. Ya ha recibido preguntas sobre su producto desde lugares tan lejanos como China y la República Dominicana.

"Mientras crecía me enseñaron a no ser mexicano, a no hablar español. No creo que suceda eso ahora. Mis hijos son bilingües y todos tienen nombres mexicanos. Mi objetivo final es dejar algo para nuestros hijos, que sea verdaderamente mexicano, y, no hay nada más mexicano que el tequila. Estoy orgulloso del tequila y ha sido una labor de amor", dijo.

El tequila auténtico debe venir de México. Él es una de cinco familias hispanas que poseen una destilería de tequila - los otros, en todo el mundo, son de propiedad corporativa.

Para comercializar su producto, comenzó a hacer llamadas telefónica a las tiendas de licores locales y les vendió con éxito el comercializar su

marca de tequila. Se estableció un objetivo, el estar en un tercio de todos los negocios en el área metropolitana y, actualmente, está en más de 40 licorerías.

Carlos Gómez, director ejecutivo y presidente de la Cámara de Comercio Hispana de Kansas City, probó la nueva línea de Mi Rancho cuando Trego se lo llevo.

Después de probarlo, decidió presentar a Trego y al dueño del Restaurante Teocali, Enrique Gutiérrez.

"Pensé que sería una buena conexión. Ambos negocios son propiedad de una familia, la clientela de Gutiérrez es muy diversa debido a la ubicación de su restaurante y tenía sentido para mí reunirlos a los dos cuando Michael lanzó su marca de tequila y quería entrar en un mercado diferente", dijo Gómez.

Una vez que Gutiérrez probó el tequila, inmediatamente supo que quería el producto en su inventario. "Tengo de 70 a 80 tequilas diferentes en mi restaurante. Tan pronto como lo olí y probé, fue increíble. Cuando toca tus labios, es muy elocuente", dijo Gutiérrez.

Gutiérrez señaló, que beber tequila ha evolucionado, de dar tragos de alcohol, a beberlo como un buen vino.

"El tequila no es lo que solía ser. Era limón y sal, luego un trago de tequila. En la última década se ha convertido en una bebida para saborear. Mi Rancho se ha convertido en mi tequila de casa, para mis margaritas", dijo.

"Lo que es único es la calidad del tequila y el precio. La presentación plateada cuesta \$19,99 dólares, la gente ve el precio y asumir que es barato, pero no lo es, es un tequila premium ofrecido a un precio bajo. Una vez que lo pruebas, te encanta", añadió Gómez.

against the finer bourbons or wines but is affordable for the consumer.

After eight years in the development stage, Trego, with the help of his wife Guadalupe, launched his own line of tequila last October. Mi Rancho Blanco, Mi Rancho Reposado and Mi Rancho Anejo Tequila brands have quickly caught the eye of the consumer.

Mi Rancho Tequila won the Spirits International Prestige (SIP) Award taking the Platinum category with 96 points out of 100 in the California competition.

"It was so neat walking into a liquor store and seeing it on the shelf. I saw someone buy it and I have been in a liquor store when someone walked in and asked for it by name. It makes you think you have some worth, some value. Life has ups and downs but it lets you know you have done something." he said

something," he said.

Mi Rancho tequila begins with estate-grown agave, which ensures a certain level of sugar content and quality of distillation. The Silver label is their blanco tequila and bottled without aging, typically suggesting the purest agave flavors. According to Trego, his silver label is made for mixed drinks.

He also is producing a tequila stored in former whiskey barrels, which helps enhance the tequila to a smoother drink.

Tequila is produced by removing the heart of the agave plant, or piña, which can weigh anywhere from 80 to 200 pounds when harvested. The heart is stripped of leaves and cooked to remove the sap, which is fermented and distilled.

Mi Rancho Tequila is an authentic premium tequila made from 100 percent blue agave in Jalisco, Mexico.

"Our tequila has the lowest methanol content in the world. Methanol is what causes a hangover. After drinking Mi Rancho Tequila for a long period of time, because of the low content, you won't have a hangover," said Trego.

He has set a goal for 2017 to grow the brand by 20 to 25 percent. He has already received inquiries about his product from as far away as China and the Dominican Republic.

There are 1,300 registered brands of tequila in the world. Getting his brand recognizable and competing against the existing brands is a major task, but Trego feels he can do it.

he can do it.

"We currently are importing about 400 cases every 60 days from Mexico. A case has 12 bottles in it. We just introduced the Mi Rancho brand. I try to make it a quality tequila at a decent

price for everyone," he said.

He hopes he can build a legacy for his family and also teach his children about their heritage and culture.

"Growing up I was taught not to be Mexican, not to speak Spanish. I don't think it is true anymore. My kids are bilingual and they all have Mexican names. My ultimate goal is to leave something for our kids that is truly Mexican and there is nothing more Mexican than tequila. I am proud of the tequila and it has been a labor of love," he said.

Authentic Tequila must come from Mexico. He is one of five Hispanic families that own a tequila distillery – the others across the world are corporate owned.

To market his product he began making cold calls to local spirit stores and successfully sold them on carrying his tequila brand. He set a goal to be in a third of all businesses in the metropolitan area and currently is in over 40 stores.

Carlos Gomez, CEO and president of the Hispanic Chamber of Commerce of Kansas City, tried the new line of Mi Rancho when Trego brought it to him.

After trying it, he decided to bring Trego and Teocali Restaurant owner Enrique Gutierrez together.

"I thought it would be a good connection. Both businesses are family owned, Gutierrez's clientele is very diverse because of his restaurant's location and it made sense to me to bring the two together as Michael launched his tequila brand and wanted to get into a different market,"

said Gomez.

Once Gutierrez sampled the tequila he immediately knew he wanted the product in his inventory.

"I have 70 to 80 different tequilas in my restaurant. As soon as I smelled it and tasted it, it was amazing. When it touches your lips, it is very eloquent," said Gutierrez.

"Tequila is not like it use to be. It was lime and salt then a shot of tequila. In the last decade it has become a drink to savor. Mi Rancho has become my house tequila for my margaritas," he said.

"What is unique is the quality of the tequila and the price. The silver brand is \$19.99 and people see the price and assume it is cheap, but it is not, it is a

premium tequila offered at a low price. Once you taste it you love it," added Gomez.

Oficiales de policía muertos en el cumplimiento de su deber

de la directora de la Comisión de Asuntos Hispanos y Latinoamericanos de Kansas (KHLAAC, por sus siglas en inglés) Adrienne Foster, después de que ella indicó, en una entrevista con Kansas City Star, su apoyó a Donald J. Trump.

Representante Estatal por Kansas, Louis Ruiz, de Kansas Kansas; El City, Representante John Alcala, de Topeka, Kansas; y, Ponka-We Victors, de Wichita, Kansas, enviaron una carta al gobernador de Kansas, Sam Brownback, quien nombró a Foster como directora, pidiendo su renuncia.

Una portavoz del gobernador Brownback, dijo que, Adrienne Foster estaba hablando como una ciudadana privada cuando hizo comentarios apoyando a Trump a un reportero del Star y, dijo, que no había razón para que renunciara.

"Como líder del KHLAAC, respaldar a un hombre que se ha referido a hispanos y latinos como traficantes de drogas, asesinos, criminales y violadores -y que se jacta de que va a construir un muro fronterizo entre Estados Unidos y Méxicoirresponsable, impensable y totalmente inaceptable", según un correo electrónico del Partido Demócrata de Kansas.

Foster no renunció a su puesto.

La victoria y la carrera presidencial de Trump han alimentado la inquietud en la comunidad latina. Su discurso de campaña sobre los muros fronterizos y las deportaciones, hizo que muchos estudiantes latinos fueran insultados en las escuelas, lo que les llevó a preocuparse por lo que les ocurriría a ellos y a sus familias.

Cientos colegiales líderes universitarios se movilizaron para defender los estudiantes emigraron a los Estados Unidos siendo niños, sin permiso legal. En noviembre se celebró una reunión en Kansas City, Missouri, donde líderes en educación comunitarios se comprometieron a dar voz a los estudiantes indocumentados

se comprometían a resistir el empujón del presidente electo Trump, para detener y deportar a integrantes de sus comunidades y poner fin al programa DACA (Acción Diferida para el Arribo de Infantes).

El miedo a un cambio en la política tiene a muchos estudiantes en un estado de animación suspendida. Algunos informes han alegado una conexión entre esos temores y un aumento en los suicidios entre los posibles afectados por el cambio.

Luis Córdoba, funcionario de las Escuelas Públicas de Kansas City, dijo: "Estamos viendo la angustia psicológica y emocional de los estudiantes en nuestras escuelas. Necesitamos crear más apoyo social y emocional para los

jóvenes".

Janet Murguía, presidenta y directora ejecutiva del Consejo Nacional de La Raza, (NCLR, por sus siglas en inglés) emitió una declaración, "Nos uniremos para luchar por nuestra voz colectiva y por lo que es correcto".

De acuerdo abogado con City, de Kansas Raymond Rico, Trump podría implementar programas inmigrantes indocumentados primer día, o dentro de los primeros cien días en el cargo. Agregó que el gobierno federal no tiene los recursos para tocar las puertas de 750 mil titulares de DACA.

La aparición del movimiento Black Lives Matter, tras la muerte de Michael Brown, en Ferguson, Missouri, en 2014, provocó protestas muchas públicas. La mayoría eran manifestaciones pacíficas, aunque hubo excepciones. Las tensiones aumentaron como resultado de una serie de muertes de civiles a manos de la policía. En algunos casos, vídeos pusieron en tela de juicio las acciones de la policía y las declaraciones posteriores muchas manifestaciones a nivel nacional.

En julio, cinco agentes de policía de Dallas, Texas, que trabajaban en una protesta pacífica por Black Lives Matter, oyeron rápidos disparos ahogar los gritos de los manifestantes y llevó a la gente a correr para cubrirse. Los agentes de policía corrieron hacia los disparos.

En el caos, doce oficiales y dos civiles fueron alcanzados por las balas. El francotirador mató a cinco de los oficiales e hirió a otros siete. Las muertes de los oficiales ha sido el mayor número de policías estadounidenses muertos en un solo incidente desde el 11 de

muertos en un solo incidente desde el 11 de septiembre. El tirador, Micah Xavier Johnson, apuntó a policías blancos en su ataque de francotirador.

Los oficiales de policía se convirtieron en blanco de disparos en Tennessee, Georgia y Missouri después de los asesinatos de hombres negros por parte de las fuerzas del orden.

ataque Tennessee ocurrió horas antes del ataque en Dallas. El agresor dijo, a las autoridades Tennesee, de estaba frustrado por los recientes asesinatos de hombres negros en Louisiana y Minnesota. Cuatro oficiales fueron heridos en un tiroteo por un atacante fuera de St. Louis, Missouri durante los altos por el

tráfico.
El KCKPD fue
sacudido por la muerte
de dos oficiales en
servicio - el capitán
Dave Melton y
el detective Brad
Lancaster.

Lancaster murió en mayo de 2016, después de que él contestó una llamada de ayuda cerca del Casino Hollywood y del Kansas Speedway. Se enfrentó al sospechoso

Curtis Ayers, de 28 años de edad, de Tonganoxie, Kansas, y se produjo un tiroteo.

Lancaster fue alcanzado varias veces en el intercambio de disparos. Lo llevaron al hospital donde la policía confirmó que murió de sus heridas.

El alcalde Mark Holland declaró en Facebook, "Él (Det. Lancaster) se puso en peligro por hacer su trabajo y perdió la vida en el proceso. Su muerte nos recuerda que nuestra comunidad depende de los servicios de emergencia, hombres y mujeres valientes, que arriesgan diariamente sus vidas por nuestra seguridad".

Ĕn julio, Melton, de 46 años de edad, un veterano con 17 años de servicio, respondió a un reporte de una persona que recibió un disparo cuando personas varias transitaban en vehículo. Cuando llegó a la escena, con otros oficiales, tres o cuatro ocupantes del coche huyeron conduciendo a una persecución de vehículos que terminó en la calle 22 y Haskell, en Kansas City, Kansas.

"El capitán Melton llegó a la escena y fue cuando los sospechosos salieron del vehículo abrieron fuego, hiriéndolo fatalmente", "Este dijo Ziegler. crimen no cae en la narrativa nacional de los ataques planeados contra oficiales de policía, pero lo hace por la narrativa cuando se trata de palabras. El odio y el discurso anti político tienen que parar porque las consecuencias reales - nuestra línea azul se ha vuelto un poco más delgada".

Ziegler habló en diciembre sobre lo que está viendo con respecto a las balaceras a la policía.

a la policía", dijo. Desde la pérdida de dos oficiales, la administración del KCKPD ha hecho cambios. Ziegler puso en práctica un requisito de que cada patrulla tenga a dos oficiales montados en cada turno. Antes del cambio, era un oficial en cada coche patrulla.

Localmente, los crímenes violentos dominaron las noticias con un aumento de asesinatos en el área metropolitana.

Un homicidio cuádruple, en Kansas City, Kansas sacudió la comunidad alegó cuando se que Pablo Antonio Serrano-Vitorino entró en la casa de su vecino, asesinando al Michael propietario Capps, además de sus amigos, Clint Harter, Austin Harter y Jeremy Waters.

Serrano-Vitorino huyó de la escena y viajó hacia St. Louis, Missouri. Él estuvo involucrado en el robo y mató a tiros a una quinta persona, Randy Nordman, de New Florence, Missouri. Fue capturado después de una persecución de 16 horas que involucró a 100 policías, unidades K-9 y un helicóptero de la policía.

Fue acusado de cuatro cargos de asesinato de primer grado, en Kansas. encarcelado Fue en el Condado de Montgomery, Missouri, con una fianza de 2 millones de dólares. El 1 de junio, se declaró inocente de la muerte ocurrida en Missouri. La pena de muerte fue solicitada en ese caso. En septiembre, un juez del Condado de Montgomery trasladó su caso de Missouri a St. Louis, Missouri para

el juicio. En el frente político local, el gobernador Kansas, Sam Brownback, inició 2016 declarando, "Kansas es fuerte". Parece que muchos constituyentes no compartieron esa creencia. Durante las elecciones recientes, los votantes tomaron una postura para detenerlo en varios proyectos de ley que afectan a las fórmulas de financiación de la educación. Los votantes estaban también preocupados por la disminución de los ingresos que afectan las proyecciones presupuesto del estatal, lo que ha

llevado a recortes presupuestarios a programas estatales como Medicaid, salud mental y proyectos de infraestructura en todo el estado.

Las colecciones

de impuestos Kansas han caído sistemáticamente. Los ingresos del estado fueron de unos \$ 350 millones menos de lo que el estado había presupuestado para gastar. El déficit de ingresos causó demócratas que republicanos pidieran moderados una revisión del código fiscal del estado.

Εl financiamiento para las escuelas de Kansas ha estado vanguardia de la batalla este año pasado. Corte Suprema de Kansas dictaminó que la fórmula que el estado utiliza para distribuir una forma de ayuda a los distritos escolares locales era inconstitucional y dio a la Legislatura hasta el 30 de junio para arreglarlo. Muchas familias en Kansas no estaban seguras de si las escuelas de sus hijos se abrirían para el año escolar.

Brownback, dijo en una declaración: "Trabajaré con el liderazgo en el Senado y la Cámara de Kansas para determinar un camino que honre nuestra tradición de proveer una educación de calidad a cada niño y que mantenga abiertas a nuestras escuelas, a nuestros maestros enseñando y a nuestros estudiantes aprendiendo".

Una tragedia, en un

popular destino turístico atrajo los titulares internacionales. tobogán de agua Verruckt, en el parque acuático Schlitterbahn de Kansas City, Kansas, estaba a 168 pies 7 pulgadas de altura y fue catalogado como el tobogán de agua más alto del mundo cuando se abrió en 2014. El tobogán está programado para ser desmantelado después de la muerte de Caleb Schwab, de 10 años de edad.

El 7 de agosto de 2016, Schwab estaba emocionado de subirse al tobogán. Desafortunadamente, perdió la vida cuando la balsa en la que estaba montando tomó vuelo, golpeando la barrera protectora que encierra al tobogán.

El parque se cerró durante la investigación y se reabrió días más tarde, pero el tobogán Verruckt fue cerrado. Schlitterbahn anunció en noviembre que Verruckt será demolido.

after she indicated she supported Donald J. Trump in a Kansas City Star interview.



Kansas State Rep. Louis Ruiz of Kansas City, Kansas; Rep. John Alcala of Topeka, Kansas and Ponka-We Victors, of Wichita,



Kansas, sent a letter to Kansas Governor Sam Brownback, who appointed Foster as director, calling for her resignation.

A spokeswoman for Governor Brownback said Adrienne Foster was speaking as a private citizen when she made comments supporting Trump to a Star reporter and said there was no reason for her to step down.

"As the leader of the KHLAAC, endorsing a man who has referred to Hispanics and Latinos as drug dealers, killers, criminals and rapists and who boasts of building a border wall between the United States and Mexico irresponsible, unthinkable and entirely unacceptable," according to an email by the Kansas Democratic Party.



Foster did not leave her office. Trump's presidential run and victory has

fueled uneasiness in the Latino community. His campaign talk of border walls and deportations had many Latino students being taunted at schools leading to concerns as to what would happen to them and their families.

Hundreds of college and university leaders mobilized to defend students who immigrated to the United States as children, without legal permission. A meeting in Kansas City, Missouri was held in November where education and community leaders pledged to give a voice to the undocumented and students pledging to resist President-elect Trump's push to apprehend and deport members of their communities and put an end to DACA (Deferred Action for Childhood Arrivals) program.

The fear of a change in policy has many students in a state of suspended animation. Some reports have alleged a connection between those fears and an increase in suicides among those possibly affected by the change.



Luis Cordoba, an official with the Kansas City Public Schools said, "We are seeing the psychological and emotional distress of students in our schools. We need to create more social and emotional support for the kids."



Janet Murguia, president and CEO of the National Council of La Raza, (NCLR) released a statement, "We will come together to fight for our collective voice and for what's right."

According to Kansas City attorney

Raymond Rico, Trump could implement his undocumented immigrant programs on day one, or within the first one hundred days in office. He added that the federal government does not have the resources to knock on the doors of 750,000 DACA holders.

The emergence of the Black Lives Matter following movement the shooting death of Michael Brown in Missouri Ferguson, in 2014 led to many public protests. Most were peaceful demonstrations though there were exceptions. The increased tensions were a result of a series of deaths of civilians at the hands of police. In some cases, video called into question the actions of the police and subsequent statements and led to many demonstrations nationally.

In July, five Dallas, Texas police officers working a peaceful protest for Black Lives Matter heard rapid gunfire drown out the protesters' shouts and send people running for cover. Police officers ran towards the gunfire.

Twelve officers and two civilians were shot in the chaos that ensued. The sniper killed five of the officers and wounded seven others. The officers' deaths were the highest number of United States police officers killed in a single incident since 9/11. The shooter, Micah Xavier Johnson, targeted white police officers in his sniper attack.

Police officers became targets for shooters in Tennessee, Georgia and Missouri in the aftermath of killings of black men by law enforcement.

The attack in Tennessee happened hours before the Dallas attack. The attacker told Tennessee authorities that he was frustrated by the recent killings of black men in Louisiana and Minnesota. Four officers were wounded in shootings by an attacker outside of St. Louis, Missouri during traffic stops.

KCKPD was rocked by the deaths of two on-duty officers – Captain Dave Melton and Detective Brad Lancaster.

Lancaster died May 2016 after he answered a call for help near the Hollywood Casino and the Kansas Speedway. He confronted 28-yearold suspect Curtis Ayers of Tonganoxie, Kansas and a gunfight ensued.



Lancaster was hit multiple times in the exchange of gunfire. He was rushed to the hospital where police confirmed he died from his wounds.

Mayor Mark Holland stated on Facebook, "He (Det. Lancaster) stood in harm's way to do his job and lost his life in the process. His death reminds us that our community depends on the first responders, brave men and women, who daily risk their lives for our safety."



In July, 46-year-old Melton, a 17-year department veteran, responded to a report of a person being shot at by several people in a vehicle. When he arrived on the scene with other officers, three or four occupants of the car fled leading to a vehicle chase that ended at 22nd and Haskell in Kansas City, Kansas.

"Captain Melton arrived on the scene as the suspects bailed from the vehicle and opened fire striking him and fatally wounding him," said Ziegler. "This crime does not fall into the national narrative of planned attacks against police officers, but it does for the narrative when it comes to words matter. The hate and anti-police speech has got to stop because the consequences are real our blue line just got a little thinner."

Ziegler spoke out in December about what he is seeing in regards to police shootings.

"I think ten years ago there was probably more respect for law enforcement, even among criminals. Bad guy robs a bank, bad guy gets cornered, then he surrenders and says, 'I have to do the time now.' I don't think that is the case now. People now for whatever reason think it is easier just to shoot it out with the police," he said. Since the loss of

Since the loss of two officers, KCKPD administration has made changes. Ziegler put into effect a requirement that every patrol car have two officers riding on each shift. Before the change, it was one officer in every patrol car.

Locally, violent crimes dominated the news with an increase of murders across the metro area.

A quadruple homicide in Kansas City, Kansas rocked the community when it was alleged that Pablo Antonio Serrano-Vitorino walked into his neighbor's home, murdering the homeowner Michael Capps along with his friends Clint Harter, Austin Harter and Jeremy Waters.

Serrano-Vitorino fled the scene and traveled towards St. Louis, Missouri. He was involved in the burglary and shooting death of a fifth person, Randy Nordman of New Florence, Missouri. He captured after was a 16-hour manhunt that involved 100 law enforcement officers, K-9 units and a police helicopter.

He was charged with four counts of first-degree murder in Kansas. He was jailed in Montgomery County, Missouri with bail set at \$2 million. On June 1, he pleaded not guilty to the Missouri killing. death penalty The was sought in that case. In September, a Montgomery County judge transferred his Missouri case to St. Louis, Missouri for trial.

On the local political front, Kansas Governor Sam Brownback kicked off 2016 stating, "Kansas is strong." It appears many constituents did not share that belief. During recent elections, voters took a stand to stop him on several bills affecting educationfunding formulas. Voters were also concerned with decreased revenues impacting state budget projections, which have led to budget cuts to state programs like Medicaid, mental health, and infrastructure projects across the state.

Kansas tax collections have consistently fallen

short. The state's revenues were about \$350 million less than what the state had budgeted to spend. The revenue shortfall caused Democrats and moderate Republicans to call for an overhaul of the state's tax code.

Funding for Kansas schools has been at the forefront of the battle this past year. The Kansas Supreme Court ruled that the formula the state uses to distribute one form of aid to local school districts unconstitutional gave the Legislature until June 30 to fix it. In June, the Legislature had to be called into a special session to pass legislation to avert the closing of the public school system. Many families in Kansas were unsure if their children's schools would open for the school year.



Brownback said in a statement, "I will work with leadership in the Kansas Senate and House to determine a path forward that honors our tradition of providing a quality education to every child and that keeps our schools open, our teachers teaching and our students learning."

A tragedy at popular 'tourist destination garnered international headlines. The Verruckt water slide in Kansas City, Kansas' Schlitterbahn waterpark stood at 168 feet 7 inches tall and was billed as the tallest water slide in the world when it opened in 2014. The slide is slated to be dismantled following the death of 10-year-old Caleb Schwab.

On August 7, 2016, Schwab was excited about riding the slide. Unfortunately, he lost his life when the raft he was riding took flight hitting the protective barrier that encages the slide.

The park closed during the investigation and reopened days later but the Verruckt slide was shut down. Schlitterbahn announced in November that Verruckt would be demolished.

Granted, you have Tyreek Hill and Travis Kelce, along with Peters flexing the superstar muscles but can you imagine them placing their own desires above that of the team?



Pedestrian **Fatalities** on the Rise

Nearly 10 percent of all Missouri traffic fatalities are pedestrian deaths.

JEFFERSON CITY, MO – Walking is an essential transportation mode for many Missourians. For transit or motor vehicle users, every trip begins and ends as a pedestrian. Public health, economic and environmental factors are elevating the importance of this mode. Many citizens do not have access to a personal vehicle, are not physically capable of driving, simply decide not to drive, or delay

To date, 83 pedestrians have been killed in Missouri traffic crashes this year. This equates to nearly 10 percent of all statewide traffic

"Motor vehicle crashes involving pedestrians don't usually occur in extremely large numbers, but when a pedestrian is involved in a traffic crash, the potential for injury or death is much greater," said MoDOT's Director of Highway Safety Bill Whitfield. "It's imperative that drivers and pedestrians use extreme caution at all times," he said.

The Missouri Coalition for Roadway Safety offers the following tips to help eliminate these

Always stay inside a disabled vehicle if it is safe to do so, so the vehicle can protect you. The vehicle is much more visible to oncoming traffic than a pedestrian standing in the roadway.

Never walk distracted by texting, talking or using headphones.

Make yourself visible to motorists by wearing light colored clothing, and always make eye contact with drivers when possible.

Always use designated crosswalks and obey crosswalk signals when available.

Motorists should slow down and move over for any vehicles stopped on the shoulder, and assume someone may be walking near that

Use extra caution and expect the unexpected. Education to the general public about these dangers, and enforcement of traffic laws will help prevent pedestrian deaths. Engineering advancements such as design, lighting, installation of crosswalk signs, pavement markings, and mid-block crossing signals, are also being used statewide, along with new technological advancements.
